They provide you with our key advice, information on stop and search and arrest, and the names and numbers of solicitors who can help you.

**We often hear stories from people who weren't carrying a bustcard as they didn't expect to be arrested. Always write the name and number of a solicitor and the GBC legal hotline on your arm. Don't be caught out!**

#### STOP & SEARCH

Before a search you must be told the name and station of the searching officer, the reason you are being searched, and what power you are being searched under.

**You do not have to give your name and address or answer questions under any stop and search power.**

Unless you are driving a vehicle, then give only name, address and date of birth. You are entitled to a receipt of the search.
